Governing Council of NITI Aayog

The Governing Council is the apex body of NITI Aayog that enables structured engagement between the Union and the States.

Composition

- **Prime Minister of India** as the Chairperson
- **Chief Ministers of all States and Union Territories with legislatures**
- **Lieutenant Governors of Union Territories without legislatures**
- **Union Ministers** as ex-officio members
- **Vice Chairperson, CEO**, and senior officials of NITI Aayog

Functions

- To discuss **national development priorities** and ensure alignment with state goals
- To deliberate on **multi-sectoral and inter-state issues**

- To monitor and guide **implementation of major policies and programs**
 - To promote innovation, performance-based evaluation, and **grassroots development**

- **Full-time members** - Appointed by the Prime Minister
