- **Publishing Requirement:** The book must be **published in the UK or Ireland within the prize year** by a **registered UK or Irish publisher**. This criterion ensures the book meets professional publishing standards. **Self-published books** are not eligible, maintaining a consistent level of literary quality and industry recognition.
- **Prize Money:** The Booker Prize provides significant financial awards:
 - **Winner's Reward:** The author of the winning novel receives **£50,000**, a substantial prize intended to support and honor their creative work.
 - **Shortlisted Authors' Reward:** Each shortlisted author also receives **£2,500**, acknowledging their literary achievement and contribution to contemporary fiction.

- **Foundation's Role:** The **Booker Prize Foundation** is a **registered charity** established in **2002**. It manages the Booker Prize for Fiction and the Man Booker International Prize, supporting and celebrating excellence in fiction.
