Who Are 'D' (Doubtful) Voters?

- **Definition:**
 - Individuals marked as **Doubtful (D) voters** during electoral roll revision.
 - Their cases are either **pending before the Foreigners Tribunal** or they have been **declared foreigners.**
 - **Introduced by:** Election Commission of India (ECI) in 1997.
 - **Legal Status:**
 - **Not defined under the Citizenship Act, 1955, or the Citizenship Rules, 2003.**
 - Exists only in electoral law and administrative procedures.

Legal Process & Citizenship Verification

- **Identification & Notification:**
 - During verification, families or individuals **suspected of being foreigners** are notified under a **pro forma.**
 - The **local registrar records their status in the Population Register** for further investigation.
- **Right to Appeal:**
 - Individuals can **challenge their classification** before the **Foreigners Tribunal.**
 - The **Taluk or Sub-district Registrar of Citizenship** ensures **due process** and provides a **hearing opportunity.**
- **Investigation Timeline:**
 - The **Registrar must complete investigations within 90 days** and submit findings.
- **Consequences of Foreign Status:**
 - If found to be **illegal immigrants or foreign nationals**, they may face:

- **Deportation.**
 - **Detention in designated centers.**
 - **Impact on Voting Rights:**
 - **D voters cannot vote or contest elections** until their status is cleared.

D Voters and NRC

- **Can D Voters Be Included in NRC?**
 - **Yes, they can apply** for inclusion in the **updated NRC**.
 - However, their names will be added **only after getting clearance from the Foreigners Tribunal** and their removal from the **D voter list in the Electoral Roll**.

Challenges and Concerns

- **Detention Centers:** Criticized for **poor conditions** and **human rights violations**.
 - **Legal Uncertainty:** The **absence of a clear definition** in citizenship laws creates confusion.
 - **Impact on Genuine Citizens:** Some **legitimate citizens face wrongful classification**, leading to legal struggles.
 - **Electoral Exclusion:** Thousands remain **disenfranchised** due to pending cases.
