- It operates as a **functional commission of the United Nations Economic and Social Council (ECOSOC)**.
- The CSW works to advance **women's political, economic, civil, social, and educational rights** worldwide.
- It also highlights urgent global issues, such as the impact of **conflict on women and girls**.

### Historical Background

- **Established: 21 June 1946**, by a resolution of ECOSOC.
- In **1996**, ECOSOC expanded CSW's mandate, making it responsible for:
  - **Monitoring and reviewing the progress of gender equality.**
  - **Overseeing the implementation of the Beijing Declaration and Platform for Action.**
  - **Mainstreaming gender perspectives into UN activities.**

### Beijing Declaration and Platform for Action

- Adopted in **1995** by **189 countries**, it remains the most **comprehensive global agenda for gender equality**.
- It sets forth strategic objectives and concrete actions to **advance women's rights** and ensure their full participation in all aspects of society.

## Annual Sessions of CSW

- The **CSW meets annually for two weeks** at the **UN headquarters in New York**.
  - Participants include **representatives from UN member states, civil society organizations, and UN entities**.
  - Discussions focus on:
    - **Reviewing progress and gaps** in implementing the **1995 Beijing Declaration and Platform for Action**.
    - **Assessing emerging gender-related issues**.

  - The **outcomes and recommendations** of the CSW session are **forwarded to ECOSOC** for further action and implementation.
